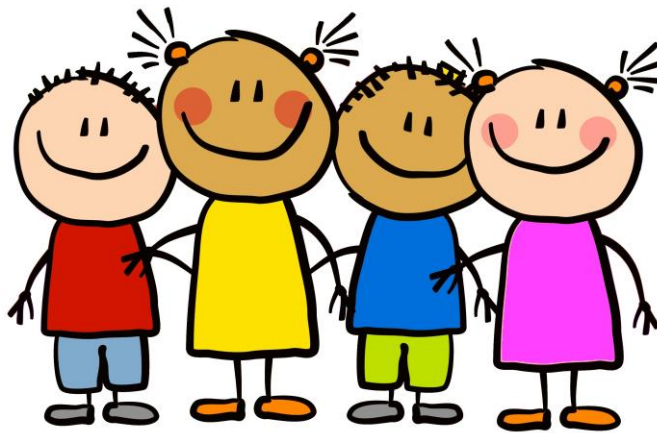

Title 1-VPK Registration Process

Step 1:

Create an account and apply for a VPK Certificate of Eligibility through the Office of Early Learning's Single Point of Entry at: <https://vpkcp.floridaearlylearning.com/>

(The Single Point of Entry System will be available beginning January 1, 2015.)

*An email notification will be sent to you once the Early Learning Coalition approves your application and your Certificate of Eligibility is ready to be printed. Print your certificate to bring with you to your registration and screening appointment.

Step 2:

Schedule a registration and screening appointment for your child to determine eligibility for a seat in a St. Lucie Public School VPK/Title 1 classroom.

Screening consists of: developmentally appropriate academic and social-emotional tools, family income, and residence verification.

Step 3:

Attend your scheduled registration and screening appointment to determine eligibility for a seat in a St. Lucie Public School VPK/Title 1 classroom. **Bring your child** and the following documentation with you to your appointment:

- ✓ Certificate of Eligibility (from Step 1)
- ✓ Child's Original Birth Certificate
- ✓ Photo Identification
- ✓ **Social Security Card (*If available*)
- ✓ *Two Proofs of Address

Parent/Guardian's name and address must be showing on the proof of address. Acceptable proofs include: One (1) Primary and One (1) Secondary or Two (2) Primary Proofs of Address. Two (2) secondary proofs of address will not be accepted.

*Proof of address is required for all applicants.
