# SLW CENTENNIAL HIGH SCHOOL – VEHICLE PARKING CONTRACT

Students: Please read each of the following statements and sign your initials on the line. By initialing on the line beside each statement you recognize that you understand and will obey all parking regulations. Upon receiving my parking permit, I the undersigned, fully understand that:

- \_\_\_\_\_ SLW Centennial High **DOES NOT** assume responsibility for motor vehicles or their contents while operated or parked on school grounds or any other designated areas.
- \_\_\_\_\_ **ONLY** students with Abbreviated Schedules may park in the west parking lot. If there are no spots available upon arrival students with abbreviated schedules may park in the east parking lot, understanding that this lot will be unlocked at designated times.
- \_\_\_\_\_ Students that **DO NOT** have abbreviated schedules **MUST** park in the east parking lot only and may **NOT** park in the west parking lot.
- \_\_\_\_\_ Student may **NOT** park at McChesney.
- \_\_\_\_\_ I must maintain at least a 2.0 GPA understanding that my driving privileges will be suspended if not maintained.
- \_\_\_\_\_ I understand excessive unexcused tardies and absences will result in loss of parking privileges. Students must maintain a 90% Average Daily Attendance (ADA) in order to maintain parking privileges.
- \_\_\_\_\_ I am not to speed or drive recklessly on school grounds.
- \_\_\_\_\_ I am not to sit in my car or loiter around my car before, after or during school hours.
- \_\_\_\_\_ During the school day, I am not to go to my vehicle or allow others to go to my vehicle (without written administrative approval).
- \_\_\_\_\_ I am not to leave school grounds during school hours without prior administrative approval.
- \_\_\_\_\_ I will not transport any unauthorized students off campus **or I will lose my permit permanently.**
- \_\_\_\_\_ I will not bring alcoholic beverages, drugs or weapons on school grounds in my vehicle.
- \_\_\_\_\_ I will not possess and/or use any tobacco products (including vapor pens) in or near my vehicle while on campus.
- \_\_\_\_\_ I will lock my vehicle while parked on school grounds.
- \_\_\_\_\_ I will display my parking decal at all times while on school property.
- \_\_\_\_\_ I must place my parking decal only on vehicles listed on my application.
- \_\_\_\_\_ I will not give or loan my parking decal to another person, understanding that **I will lose my permit permanently.**
- \_\_\_\_\_ BIC or OSS from school my result in driving privileges being suspended or revoked.
- \_\_\_\_\_ If my car is towed for being illegally parked, I will be responsible for the towing charges.
- \_\_\_\_\_ If I am involved with duplicating parking decals (including my own) I will be subject to school consequences.
- \_\_\_\_\_ I have read the parking rules and regulations in the 2017/2018 Student Handbook and will accept the consequences for driving/parking infractions & policies.
- \_\_\_\_\_ I REALIZE THAT DRIVING TO SCHOOL IS A PRIVILEGE, NOT A RIGHT. This privilege may be suspended or revoked if the above rules are not obeyed, or if my behavior at school indicates that I am not responsible enough to deserve this privilege. I agree to all the terms and conditions outlined in the contract.

## SLW Centennial Parking Application 2017 – 2018

Fill out this form, and submit it to Q118. Student driver AND parent/guardian signatures are **REQUIRED** for processing. **Parking applications will not be accepted without a copy of student driver license and a copy of proof of insurance and a \$30 fee in cash. Checks or other forms of payments other than cash will not be accepted.**

Students with abbreviated schedules may park in the east or west student parking lots. Students that do not have abbreviated schedules are only allowed to park in the east parking lot. Both student parking lots will be open from 6:45 AM until 1:45 PM. Students may not park as the McChesney Lot that is located directly south across the road from the school, nor in the visitor parking lot on the west side of campus. Dual Enrollment and abbreviated schedule students will be required to arrive and depart through the main office area signing in and out.

**School assigned parking is a PRIVILEGE, not a right.** Parking permits may be revoked if students do not abide by all local and state motor vehicle laws. Students are expected to adhere to the rules in the Centennial Student Handbook. Violation of such said rules may result in parking privileges being revoked. District attendance policies must be adhered to in order to maintain the parking permit. **Consequently, students must maintain at least a 2.0 GPA to keep the parking privilege. In addition, students have excessive unexcused absences and/or tardies and do not have an average daily attendance (ADA) will have their in parking privileges revoked.**

Students parking in unauthorized areas may have their vehicle towed at the owners expense, and will lose their parking privileges for the remainder of the school year. Students and parents acknowledge that parking is at their own risk. The School and School Board are not responsible for any damages to vehicles or to the vehicle's contents. Students are not to "hang out" in the parking lots. Students **MUST** have administrative permission to return to their car or to the parking lots during the school day. The student parking lots are school board property, and **ALL** school rules/policies apply.
