The Homecoming Dance 2025 rules and regulations are as follows:

1. DRESS CODE:

- Dress pants or Jeans are required (no holes, no sweatpants)
- Ties, bowties, or other dress accessories are **optional**.
- No hats
- Dress length must be no more than 5 inches above the mid knee.
 - (Where the dress naturally falls)
- Backs may NOT be exposed below the mid-line.
- Dresses **NOT** allowed: low necklines, cut outs, high dress slit, midriff showing or 2 piece.
- NO bags larger than a sheet of paper.

NO EXCEPTIONS. If the student is not in proper attire, he/she/they will not be admitted.

No refunds will be given. Choose your attire wisely and follow the rules!

2. Tickets are **non-transferable** and **non-refundable**. At check-in you must show a school ID.
 - a. The photo identification must match the name of the ticket holder.
3. Fort Pierce Central Homecoming Dance is restricted to **CURRENT** Fort Pierce Central students.
 - a. Students from other schools are not allowed and will be dismissed.
4. Students with a discipline record of a level 3 incident or higher from September 17th through October 17th will be prohibited from purchasing a ticket or attending.
5. Tickets are to be purchased at school with cash, check, or school pay – in person only.
 - a. **No tickets will be sold at the door.**
6. No one will be admitted to the Homecoming Dance **after 8:00pm**.
 - a. No refunds will be given for late arrivals. There will be no re-entries.
7. The Homecoming Dance is a school sponsored event. THE SCHOOL ADMINISTRATION RESERVES THE RIGHT TO DENY ANYONE ENTRANCE. **Cigarettes, vape pens, alcohol, weapons, drugs, and lighters are not permitted on the school campus.**
