Dress Code Guidelines

- Dresses must be no shorter than three inches above the knee.
- Slits must be no higher than three inches above the knee.
- Excessive cleavage or deep plunging necklines are prohibited.
- Two-pieced dresses and cut-outs may not expose more than one inch of mid-drift.
- Open back dresses may not expose the lower-mid back (draw invisible line from your belly button around your back – do not expose below this line)
- Attire with regional / national flags is prohibited.

****Fort Pierce Central High School reserves the right and final authority to decide what is deemed appropriate. If clothing is deemed inappropriate and is NOT listed above, or if clothing is identified by law enforcement as promoting unlawful activities, school officials can/will enforce consequences, including removal from the dance.***

Behavior Policy

- The FPCHS Prom is a St. Lucie County Public Schools sanctioned event; therefore, all rules, policies, and procedures outlined in the St. Lucie County Public Schools Code of Conduct will be strictly enforced.
- Any student under the influence or in possession of any illegal substance, or paraphernalia associated with these substances, including, but not limited to alcohol, illegal drugs, tobacco or vapes, etc..., will be referred to local law enforcement and subject to prosecution.
- Weapons of any kind are strictly prohibited. Any student who violates this policy will be referred to law enforcement and subject to prosecution.
- Party buses, limousines, and personal vehicles with reasonable suspicion may be subjected to searches.
- Dancing deemed sexually lewd, promiscuous, or suggestive in any form is strictly prohibited.

****If a student is in violation of any of the above-mentioned infractions, the student will be removed from the dance and must be immediately picked up by a parent or guardian. NO REFUNDS will be issued. Students may receive out-of-school suspension and may be prohibited from participating in any future school-related activities/events.***

***All FPCHS students and guests must present a school or state-issued photo ID to enter the event.**

***Any student not picked up within 15 minutes after 11:00 PM, may be prohibited from attending future school events.**
