ENTERING CAMPUS

- ❑ All students must enter the campus through the bus loop (located on the East side) or the Parent drop-off area (located on the West side) every morning.
- ❑ Students who arrive after the 7:33 AM bell will enter campus through the West Side doors.
- ❑ Students who arrive after 8:00 AM will enter campus through the Front Office.



EXITING CAMPUS

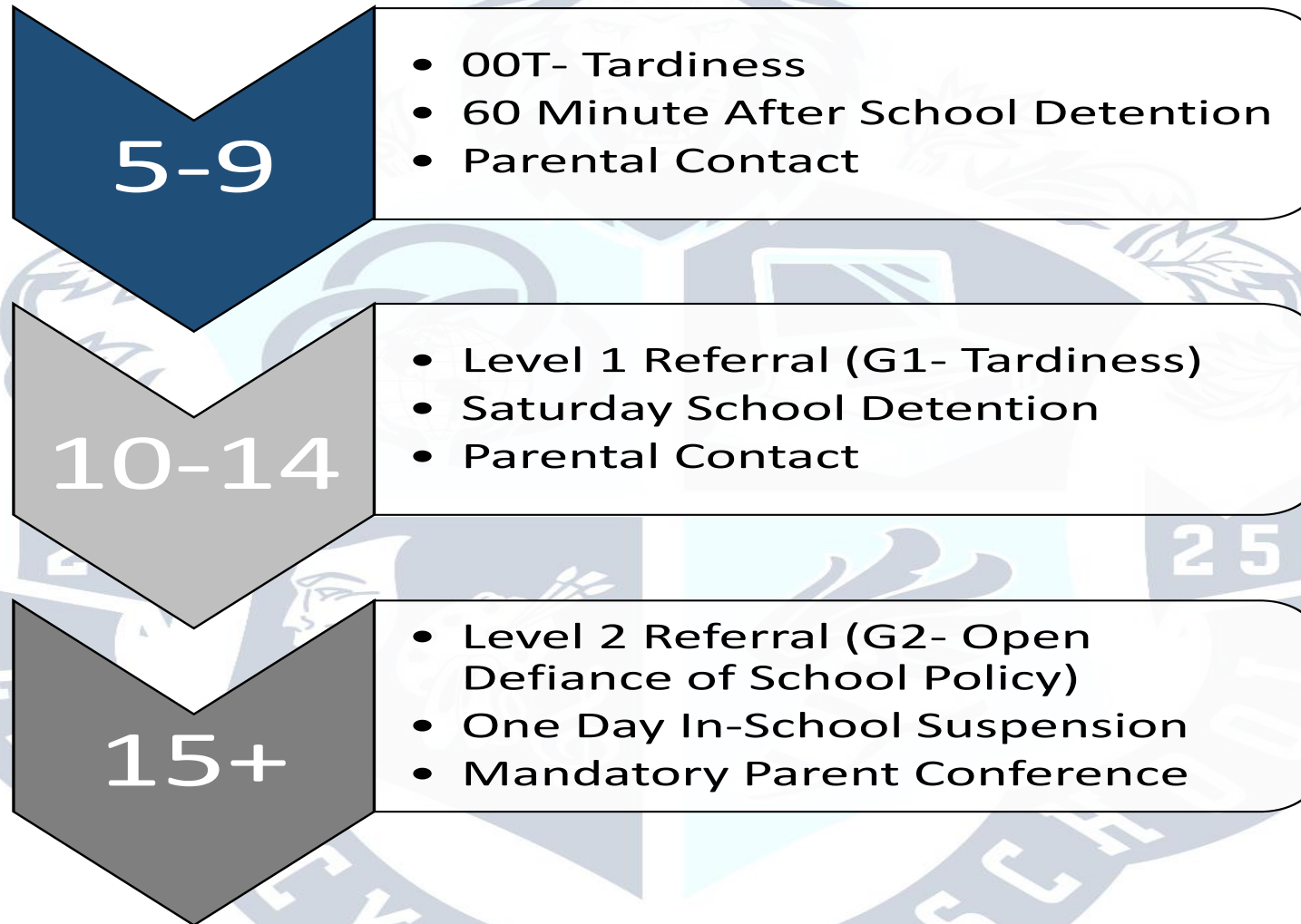
☐ Closed campus:

- ☐ All schools in Saint Lucie County are closed campuses. This means you must sign out with the front office with parental permission to leave campus any time during the school day.
- ☐ If you are skipping off campus and return consequences may be more severe.
- ☐ Dual Enrollment students who leave before the end of the school day will exit campus through the front office.

Reports pulled every Friday to identify tardy count. Student tardy count resets weekly. Student consequence count resets quarterly. Students who accumulate multiple weekly infractions will receive progressive disciplinary consequences.

SAFETY 1ST

❑ Safety 1st:

- ❑ Don't open exterior doors for anyone- staff, students, or otherwise – during the school day.
- ❑ Consequences for both those entering and those opening the door for others to enter.
- ❑ Ask Deans, AP's, office staff, SRO/SRD on how to handle special situations.



CAFETERIA AND FOOD POLICY

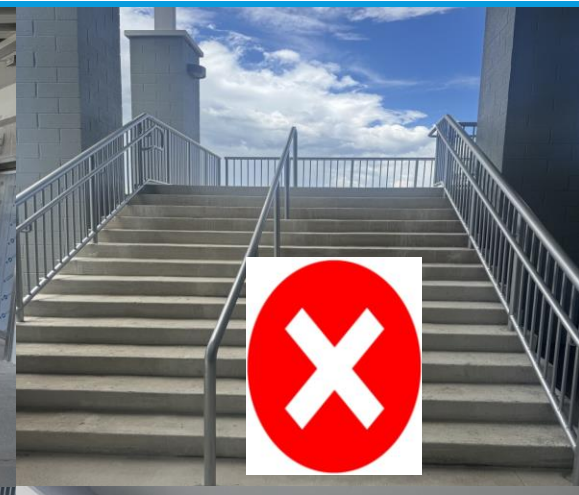


- ☐ During the lunch period, students are required to remain on campus.
- ☐ Food is not permitted in the building or classrooms
- ☐ No food deliveries of any kind are permitted during school hours.




Students must remain in designated, supervised areas during lunch period (inside and outside)

Students are not permitted on the stairs, in the bus loop or on the 2nd floor.



DRESS CODE

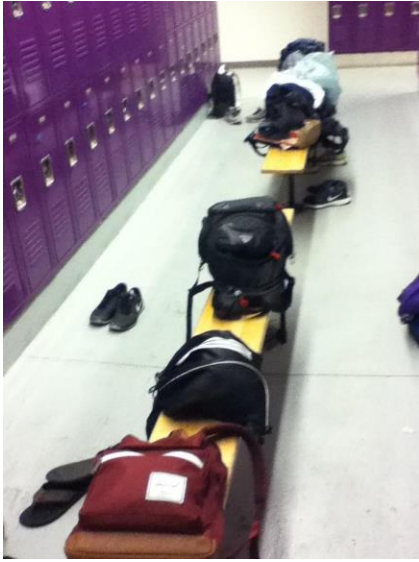
-  Quick Highlights:
- Student ID badges must be worn and visible at all times.
- No sheer or see-through fabrics, crop tops, or clothing that reveals undergarments.
- No shorts or skirts above fingertip length.
- No clothing or accessories that promote drugs, violence, or unsafe behavior.
- Backless shoes are not recommended due to safety concerns in high-traffic areas.

Legacy High School Student Dress Code 2025-2026

All Students MUST:	Students are NOT permitted to wear:
<p>Be covered from shoulders to fingertip length on the thigh. This includes any bottoms that have rips or frays. Shorts and skirts above fingertip length and crop tops are not permitted. Students must wear their student IDs around their necks upon arrival to school and throughout the school day.</p>	<ul style="list-style-type: none"> • Sheer (see-through) fabrics, including fishnet material, thigh highs, and very tight clothing. • Undergarments must not be visible or outlines (through both loose and form fitted clothing). • All tops including, but not limited to sleeveless shirts, tanks or camisole tops, or shirts that expose the midriff, shoulders, or cleavage, including crop tops or shirts with cutouts. • Clothing or accessories that are offensive, promotes violence, alcohol, tobacco, drugs or has the potential to compromise safety. • All bottoms above fingertip length including, but not limited to athletic shorts, skirts, flat front shorts, etc. • Jewelry/Accessories considered unsafe or inappropriate for school (For example, brass knuckle type rings, studded belts, garter belts, chains on pants, etc.) • Sunglasses while indoors <p>**Backless shoes are not recommended to be worn at school due to stairs and large crowds of students. Students who choose to wear backless shoes are doing so at their own risk.</p> <p>** Teachers may designate days for Professional Dress. These days must adhere to the school dress code.</p>

EDIBLES

- What Are Edibles?
 - Edibles is the term used to refer to any type of food products that contain cannabis, the active ingredient in marijuana
- Symptoms
 - Fast heart rate
 - Difficulty breathing
 - Feelings of anxiety, panic or paranoia
 - Nausea or vomiting
 - Dizziness or weakness
 - Poor coordination
 - Seizures or coma (in rare cases)



CONTRABAND



These are just some of the items that are not allowed on your person, in your bag, or in your vehicle - if parked on campus.



ADDITIONAL CONTRABAND

- ❑ ****Medications**:** Students cannot carry prescription or over-the-counter medications. All medications must be stored in the clinic, with annual approval from parents or guardians through medication forms.
- ❑ ****Note:**** Students may possess and use FDA-approved medications for headaches or menstrual cramps on school property or at school events without a physician's note or prescription.



SOCIAL MEDIA / ELECTRONICS

- Misuse of Electronic Devices –
 - This applies to school or private devices and applications used in violation of the student code of conduct
 - Examples include but are not limited to: threats, bullying & harassment, inciting fights, spreading rumors, unauthorized recording or picture taking.

REMEMBER: Your electronic footprint can never be completely erased!



FIGHTING

- ❑ Will result in a 10-day out-of-school suspension and law enforcement consequences.
- ❑ - Don't start a fight (verbally or otherwise), don't try to break up a fight, if you need to talk it out on campus, get assistance with mediation.



ADDITIONAL EXPECTATIONS

❑ Restrooms

- ❑ Single use ONLY. More than one person in the restroom at a time is a violation of school policy and will result in disciplinary action.
- ❑ Don't be in the restroom together to console someone, give a needed item, watch or make a TikTok, skip, etc... If there is a true need, ask Deans, AP's, office staff, SRO/SRD on how to handle special situations.





BUSES AND DISMISSAL

- Know your bus #.
- Buses leave 5 minutes after the dismissal bell.
- When you enter the bus loop areas have your headphones out of your ears and leave them out until you've boarded your bus so you can hear if there are any bus changes.
- Buses and bus stops are an extension of the school. Therefore, rules and consequences still apply.

PARKING PERMIT

Driving and parking on campus is a privilege, not a right.

Students who use the school parking lot do so at their own risk. Neither the school nor the school board is responsible for any damage, loss, or theft involving vehicles parked on school grounds.

Student Parking Rules

-  No assigned spots — students must park only in designated student areas.
-  Do not park in staff or visitor areas — doing so will result in disciplinary consequences.
-  Parking placards must be displayed on the rearview mirror at all times.
-  No placard = No parking — vehicles without placards after August 25th are subject to being booted or towed at the owner's expense.
-  All vehicles must exit campus by 2:00 p.m. unless the student is participating in a school-approved after-school activity.
-  Do not return to vehicles during the school day unless given administrative permission.
-  Drive safely — no speeding (limit is 5 MPH), cutting across spaces, or unsafe behavior.
-  No unauthorized student transportation — taking others off campus without proper credentials will result in a loss of privileges.
-  Dual Enrollment or abbreviated schedule students must enter/exit through the Front Entrance and must always carry and show their student ID.
