To Whom It May Concern:

Student SAFETY is our primary concern. It is expected that students will follow all traffic rules and regulations, report reckless driving, and keep alert while driving.

Parking is a privilege extended to students. As a privilege, students and their parents/guardians agree to abide by the driving/parking rules and regulations of Mosaic Digital Academy and Windmill Point Elementary, the Saint Lucie County School Board, and the State of Florida.

Parking at Mosaic Digital Academy during the school day is by permit only. Parking without a permit may result in a parking ticket, booting or towing of the vehicle at the driver's expense. Parking/driving violations, traffic accidents, and student disciplinary referrals may result in the loss of parking privileges.

All applications will be accepted and processed on a first come, first serve basis until all parking spaces have been issued:

After all documentation is complete and submitted to the school principal, the paperwork will be reviewed and either approved or disapproved. If it is disapproved, the student will be contacted and informed of the deficiency. After the principal has approved the paperwork, the student will be issued a parking permit.

Students will park in the parking lot at Minsky Gymnasium next to the school which is owned by St. Lucie Public Schools. Students must park properly in a designated parking space. If the student or passengers require handicapped parking they may park in any handicap designated parking space closest to the front entrance of the school.

Student Parking Policies

Parking on campus is a privilege afforded to the students of Mosaic Digital Academy. Parking permits give the holders permission to park on campus Monday-Friday. Any student violating parking lot rules may have his/her driving privileges suspended or revoked. The school assumes no responsibility for loss or damage to any vehicle (car, truck, bicycle or its contents) operated or parked on the school's campus.

Registration of Vehicle and Parking Permits

- **Effective August 2018-2019 school year:**
- All motor vehicles operated by students on Mosaic Digital Academy School's campus must display a current permit. Regular parking permits shall be placed on the front **dashboard** on the passenger side. While parked on campus, permits should be visible at all times.
- **Parking permits are obtained from our school office.** A driver's license, car registration, insurance, and schedules are required to obtain a permit.
- There is no Cost for a parking permit at this time.
- Students must have a parking permit displayed on their dashboard of their cars while parked at Minsky Gym or on campus. Periodic checks for parking permits will occur and students who bring their vehicles on campus without permits will be ticketed and their vehicle may be booted or towed and referred to the Administration Office.
- If a student already has a **2018-2019** parking permit and drives a new vehicle, the old parking permit must be updated upon the next day on campus.

State Education Statute #8133PAR.#3

Students that use the school parking area to park their private vehicles will "PARK AT YOUR OWN RISK". The school board and school administration assumes no responsibility for loss or damage to vehicles parked on school grounds, nor are they responsible for articles stolen from vehicles.

If issued a parking permit: I promise to obey the following parking rules and regulations:

1. Close all windows in my car immediately upon parking.
2. Lock the car when in the school parking lot.
3. Take all books and materials for the day with me before entering the school.
4. Stay out of the car except when officially excused.
5. Do not permit others to use the car. (Either to sit in or drive).
6. Drive carefully and slowly while coming to and going from school.
7. Not smoke anywhere on school grounds.
8. Park only in area assigned by school officials.
