Parent Notification Letter

Right to Know Professional Qualifications of Teachers and Paraprofessionals

Dear Parent,

In accordance with ESEA Section 1111(h)(6) PARENTS RIGHT-TO-KNOW, Northport K-8 School is notifying every parent of a student in a school that receives federal funds, that you have the right and may request information regarding the professional qualifications of your child's classroom teacher. This information regarding the professional qualifications of your child's classroom teachers including, at a minimum, the following:

1. Whether the teacher has met State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction.
2. Whether the teacher is teaching under emergency or other provisional status through which State qualification or licensing criteria have been waived.
3. The baccalaureate degree major of the teacher and any other graduate certification or degree held by the teacher, and the field of discipline of the certification or degree.
4. Whether the child is provided services by paraprofessionals and, if so, their qualifications.

If at any time a teacher not highly qualified has taught your child for four or more consecutive weeks, the school will notify you. If you have questions, please feel free to contact the school at 772-340-4700.

1. Si el/la maestro(a) ha cumplido con los criterios estatales de calificación y licencia para los niveles de grado y las áreas temáticas en las que el maestro(a) proporciona instrucción.
2. Si el/la maestro(a) está enseñando en situación de emergencia u otro estado provisional a través del cual se ha renunciado a los criterios estatales de calificación o licencia.
3. El grado de bachillerato del maestro(a) y cualquier otra certificación o título de posgrado en poder del maestro(a), y el campo de disciplina de la certificación o título.
4. Si el niño(a) recibe servicios de paraprofesionales y, de ser así, sus calificaciones.

Si en algún momento un maestro(a) no altamente calificado le ha enseñado a su hijo(a) durante cuatro o más semanas consecutivas, la escuela se lo notificará.
