Meal application is REQUIRED to receive a meal benefit each school year (Starting on July 1st)

Benefits For Students

- Discounted college application fee
- Summer & after school meals
- Free waivers for SAT/ACT/PSAT exams
- Discounted bus passes, internet, and phone services for parents and students

Benefits for Schools

- Increase school funding
- O Discounted internet fees for schools
- Equipment grants to improve meal quality
- Increase after school program funding

You should complete a meal application for your child if you are income eligible (see chart below) or if they are foster children, homeless, a migrant, a runaway or if they receive any of the following:

- Supplemental Nutrition Assistance Program (SNAP) benefits
- Food Distribution Program on Indian Reservations (FDPIR)
- Temporary Assistance for Needy Families (TANF)
- **Medicaid**
