 - 5. Completed application to Q118-Dean's Office (bring with you!)
- 6. You must come to Q118 to receive your decal after you email information.

SEND license and insurance IN **ONE** EMAIL WITH YOUR FIRST AND LAST NAME IN SUBJECT LINE!! Do this prior to coming into Q118. Be respectful that the staff in Q118 will only accept completed applications as we do not have time to ask questions or make copies.

You may pay **CASH** or go to schoolpay.com. You must show your receipt for schoolpay.com on your phone when you bring in COMPLETED application to Q118.

If you are a full-time student you will pay \$30, DA/AB you will pay \$20. Do not attempt to purchase a DA/AB decal if you are full time as you will be bringing your schedule with you! You will lose the right to park on campus if you try to be sneaky with our process! There are no "discounts." The amounts will remain the same throughout 2025-2026. If you lose your decal you will need to replace the decal for \$5 in Q118.

PLEASE NOTE: Parking on campus is a privilege, not a right!

SLW CENTENNIAL HIGH SCHOOL 2025/2026 - STUDENT PARKING&DRIVING POLICIES

- 1. SLW Centennial High **DOES NOT** assume responsibility for motor vehicles or their contents while operated or parked on school grounds or any other designed areas.
- 2. ONLY students with DA/AB schedules may park in the FRONT parking lot(big lot and smaller front lot). If there are no spots available upon arrival students must park in the back parking lot. Understand that the back lot gate will be unlocked at designated times to allow students to leave and enter campus. DO NOT PARK IN STAFF DESIGNATED SPOTS.
- 3. Students who are FULL TIME <u>MUST</u> park in the **BACK PARKING LOT** only and may <u>NOT</u> park in the **FRONT** parking lots. Parking in the front lot will result in discipline consequences.
- 4. Student will **NOT** park at Mc Chesney OR SLW K8 School.
- 5. I am not to speed or drive recklessly on school grounds.
- 6. I am not to sit in my car or loiter around my car before, after or during school hours.
- 7. During the school day, I am not to go to my vehicle or allow others to go to my vehicle (without written administrative approval).
- 8. I am not to leave school grounds during school hours without prior administrative approval.
- 9. I will not transport any unauthorized students off campus.
- 10. I will not bring alcoholic beverages, drugs or weapons on school grounds in my vehicle.
- 11. I will not possess and/or use any tobacco products (including vape pens) in or near my vehicle while on campus.
- 12. I will lock my vehicle while parked on school grounds.

- 13. I will display my parking decal always while on school property.
- 14. I must place my parking decal only on vehicles listed on my application.
- 15. I will not give or loan my parking decal to another person, understanding that I will lose my permit permanently.
- 16. If my car is towed for being illegally parked, I will be responsible for the towing charges.
- 17. If I am involved with duplicating parking decals (including my own) I will be subject to school consequences.
- 18. I have read the parking rules and regulations in the 2024-2025 Student Handbook and will accept the consequences for driving/parking infractions & policies.
- 19. I REALIZE THAT DRIVING TO SCHOOL IS A PRIVILEGE, NOT A RIGHT. This privilege may be suspended or revoked if the above rules are not obeyed, or if my behavior at school indicates that I am not responsible enough to deserve this privilege. I agree to all the terms and conditions outlined in the contract.
